**STATEMENT OF CONFIRMATION OF ASSIGNMENT AND
SUCCESSION IN INTEREST TO ASSETS
FROM OZARK AREA COUNCIL OF AMERICAN YOUTH HOSTELS, INC.
TO GATEWAY COUNCIL OF HOSTELLING INTERNATIONAL –
AMERICAN YOUTH HOSTELS**

This Statement of Confirmation of Assignment and Succession in Interest is executed as of the date first written above, by the undersigned, being a majority of the board of directors of Gateway Council of Hostelling International – American Youth Hostels, a Missouri non-profit corporation (“Gateway Council”), being the successor to Ozark Area Council of American Youth Hostels, Inc., a Missouri not-for-profit corporation (“Ozark Area Council”).

A. Ozark Area Council was incorporated on May 13, 1960 as a Missouri not-for-profit corporation.

B. The Missouri Secretary of State instituted a forfeiture of the Ozark Area Council which took effect January 1, 1990.

C. Ozark Area Council continued as a forfeited corporation from and after January 1, 1990 by and through its directors and officers, commencing with directors and officers of the Ozark Area Council who were in office on the date the forfeiture occurred, followed by those who succeeded in office to such directors and officers.

D. Ozark Area Council continued to own its assets from and after January 1, 1990, except for those assets specifically disposed by Ozark Area Council during the course of its regular operations. Such continuity of ownership is evidenced by, among other things: (i) the continued control and/or physical possession by Ozark Area Council of such assets; and (ii) the filing of federal tax returns (Form 990) under Ozark Area Council’s corporate name and federal taxpayer identification number. The assets which continued to be owned by Ozark Area Council during such time included, among other things, all right, title and interest in and to the federally registered trademark “MOONLIGHT RAMBLE” (Federal Registration Number 1304199) (referred to herein as the “Mark”).

E. Gateway Council was incorporated on May 11, 1998 to succeed in interest to Ozark Area Council. The Articles of Incorporation of Gateway Council provide in relevant part: “This corporation is organized and incorporated specifically to be the successor to Ozark Area Council of American Youth Hostels, Inc., Missouri Not-for-Profit Corporation No. NP002624, and as such hereby assumes all assets and liabilities, rights, duties, status and relationships of such organization.”

F. In accordance with the Articles of Incorporation of Gateway Council, Gateway Council has continued the operations of Ozark Area Council and succeeded to Ozark Area Council to all of the rights and all assets previously owned by Ozark Area Council, including the Mark. The transfer of such assets from Ozark Area Council to Gateway Council and the subsequent ownership of such assets by Gateway Council is evidenced by, among other things: (i) the aforesaid statement from Gateway Council’s Articles of Incorporation; (ii) the acquiescence in the transition by the directors and officers of Ozark Area Council who subsequently became the officers and directors of Gateway Council; (iii) the continued control and/or physical possession by Gateway Council of all such assets; (iv) the filing of federal tax returns by Gateway Council, commencing in the year 1999, which reflect the assets and activity of the Ozark Area Council from prior tax years; (v) the determination by the Missouri Department of Labor and Industrial Relations, Division of Employment Security, that Gateway Council has acquired

and has continued substantially all of the business of Ozark Area Council; and (vi) the continuation of the same events and activities formerly carried out by the Ozark Area Council, particularly the "Moonlight Ramble" and the "Cycle Across Missouri".


G. This statement is made for the purpose of clarifying the corporate records of the Gateway Council. In furtherance of that purpose, and although the transfer of assets from Ozark Area Council to Gateway Council has already been effectuated based on the evidence described above, to the extent they are empowered by applicable Missouri law to do so (including any applicable provisions of former Section 355.507 of the 1990 Missouri Statutes, which provides in relevant part that the directors and officers in office when a forfeiture occurs have full authority to wind up its affairs and to sell and liquidate its property and assets), the undersigned directors, being the successors to the directors of Ozark Area Council, and on behalf of Ozark Area Council, hereby grant, bargain, sell, convey, transfer and assign unto Gateway Council all right, title, interest and benefit in and to all assets owned by or associated with Ozark Area Council, including without limitation the Mark. The foregoing assignment shall have an effective date of May 11, 1998, the date on which Gateway Council succeeded to Ozark Area Council.

The undersigned directors have executed this instrument as of the date first above written.
