**TERMINATION AND RELEASE**  
**OF TRADEMARK SECURITY INTEREST**

**JA BRO BATTERIES, INC.**

**TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of August 18, 2005, by **HARRIS, N.A.** (successor to **HARRIS TRUST AND SAVINGS BANK**), an Illinois banking corporation with its head office at 11 West Monroe Street, Chicago, IL 60603, as Lender (hereinafter in such capacity, the "Lender") in connection with the Promissory Note (the "Promissory Note"), dated as of January 16, 2004, from Casey Holdings Limited (f/k/a Sandco 799 Limited) ("Casey") to the Lender.


**WHEREAS**, Ja Bro Batteries, Inc., an affiliate of Casey (the "Company") and the Lender entered into a Trademark Security Agreement, dated as of December 3, 1998 (the "Trademark Agreement"), which Trademark Agreement was recorded December 10, 1998 with the United States Patent and Trademark Office at Reel 1824, Frame 0333 for the purpose of securing payment and performance of certain obligations of Casey to the Lender;

**WHEREAS**, pursuant to the Promissory Note and the Trademark Agreement, the Company granted to the Lender a security interest in, and granted, assigned and conveyed to the Lender, by way of collateral security, the Company's entire right, title and interest in and to, the pledged trademarks as assigned in the Trademark Agreement; and

**WHEREAS**, the Lender has agreed to terminate and release the Trademark Agreement and assign and transfer to the Company its right, title and interest in the pledged trademarks as herein provided;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby terminates and releases the Trademark Agreement and assigns and transfers to the Company, without representation, warranty or recourse, all of the Lender's right, title and interest in and to the pledged trademarks, including without limitation the trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.

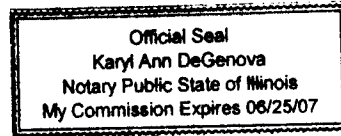
