TRADEMARK ASSIGNMENT

Box 6126, Hilton Head, South Carolina, 29938-6126, hereinafter referred to as Assignee, is desirous of acquiring said service mark, together with the goodwill of the business symbolized by said service mark;

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby acknowledges that it has sold, transferred, conveyed, and assigned unto said Assignee the entire right, title, and interest in and to said service mark, all registrations and applications for registration of said service mark, including specifically herein before identified, all domain name registrations of said service mark; the right to recover for past infringement of said service mark; and the goodwill of the business in connection with which said service mark is used and which is symbolized by said service mark.

ASSIGNOR HEREBY covenants and represents that ASSIGNOR has the full right to convey the entire interest herein assigned, and that ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith.

ASSIGNOR HEREBY covenants and represents that ASSIGNOR has been the sole and exclusive user of the service mark for the services set forth above from the time of ASSIGNOR'S adoption of said service mark; that ASSIGNOR has continually used the service mark since the time of its adoption by ASSIGNOR and the ASSIGNOR has not abandoned the same; that ASSIGNOR has continually policed the entity to use the same or any confusingly similar marks for the same or related goods or services; that to the best of ASSIGNOR'S knowledge, information and belief, neither the service mark nor any confusingly similar marks are currently used by any other person, firm, company, or entity, whether related to or affiliated with ASSIGNOR or not, for similar or related goods or services has not been so used by any other person, firm, company, or entity during the time of ASSIGNOR'S use

ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to the said ASSIGNEE, its successors, legal representatives, and assigns, any facts known to ASSIGNOR respecting said marks, and testify in any legal proceeding, sign all lawful papers, execute all applications for registration, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives, and assigns, to obtain and enforce proper protection for said trademark in all countries.
