TRADEMARK AND SERVICE MARK ASSIGNMENT

3. This Assignment shall be construed in accordance with the laws of the State of New York, without regard to the principles of conflicts of law thereunder.

4. This Assignment may be executed in several counterparts, each of which shall constitute one and the same instrument.


