**RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks, dated as of June 29, 1999, is executed by Fleet Bank, N.A. (as successor in interest to NatWest USA Credit Corp.), as the lender (the "Lender") under that certain Loan and Security Agreement dated as of June 29, 1989 (the "Loan and Security Agreement"), among the Lender, Big Bear Stores Company ("Big Bear") and Hart Stores, Inc. ("Hart Stores").

WHEREAS, to secure the performance of Big Bear's and Hart Stores' obligations under the Loan and Security Agreement, each of Big Bear and Hart Stores has entered into the following Collateral Assignments of Trademarks:

- (i) Collateral Assignment of Trademarks dated as of June 29, 1989 and recorded in the PTO as of July 3, 1989 at Reel/Frame 0658/0625, pursuant to which Big Bear granted a security interest to the Lender in the Trademarks, Foreign Trademarks and Future Trademarks (as defined therein), the goodwill associated therewith and certain other assets with respect to the Trademarks, Foreign Trademarks and Future Trademarks, including the trademarks set forth in Schedule 1 attached hereto (collectively, the "Big Bear Trademark Collateral") and
- (ii) Collateral Assignment of Trademarks dated as of June 29, 1989 and recorded in the PTO as of July 3, 1989 at Reel/Frame

0658/0322, pursuant to which Hart Stores granted a security interest to the Lender in the Trademarks, Foreign Trademarks and Future Trademarks (as defined therein), the goodwill associated therewith and certain other assets with respect to the Trademarks, Foreign Trademarks and Future Trademarks, including the trademarks set forth in Schedule 2 attached hereto (collectively, the "Hart Stores Trademark Collateral")


WHEREAS, Big Bear and Hart Stores have requested that the Agent relinquish, release and discharge any and all interest it may have in the Big Bear Trademark Collateral and the Hart Stores Trademark Collateral and the Agent has agreed to do so.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Fleet Bank, as Lender, relinquishes, releases and discharges, without any recourse, representations and warranties, its security interest in, to and under the Big Bear Trademark Collateral and the Hart Stores Trademark Collateral, including the trademarks and the goodwill associated therewith as set forth on Schedule 1 and Schedule 2 attached hereto.
