## RELEASE OF TRADEMARK SECURITY AGREEMENT SUPPLEMENT

(Second Lien)

This Release of Trademark Security Agreement Supplement dated as of August 17, 2005 ("Release"), is made by Bank of America, N.A., in its capacity as administrative agent under the second lien Credit Agreement dated as of July 30, 2004, among Power Well Services, Inc., the guarantors party thereto, and the lenders and agents from time to time party thereto (in such capacity, "Administrative Agent") in favor of Power Well Services, L.P., a Texas limited partnership f/k/a Power Chokes, L.P. ("Debtor").

### RECITALS

WHEREAS, Administrative Agent and Debtor previously entered into that certain Trademark Security Agreement Supplement dated July 30, 2004, recorded in the United States Patent and Trademark Office on November 16, 2004 at Reel 2975, Frame 0819 (the "Security Agreement Supplement"), pursuant to which Administrative Agent purportedly owns a security interest in, among other things, Debtor's Trademarks (as defined in the Security Agreement Supplement), including those registered U.S. Trademark Applications and Registrations of the Debtor associated with such Security Agreement Supplement that are listed in the attached Exhibit A.

WHEREAS, the Administrative Agent desires to release its security interest in the registered U.S. Trademark Applications and Registrations listed in the attached Exhibit A.

**NOW, THEREFORE, subject to the terms, conditions, covenants and provisions of this Release, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:**
