Articles of Amendment

Article 1 -Name

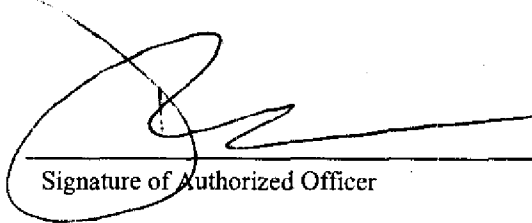
