**TRADEMARK SECURITY AGREEMENT**

This TRADEMARK SECURITY AGREEMENT, dated as of June 30, 2004 by ACTION PERFORMANCE COMPANIES, INC., an Arizona corporation ("APC" or "Company"), ACTION RACING COLLECTABLES, INC., an Arizona corporation ("ARC"), ACTION SPORTS IMAGE, L.L.C., an Arizona limited liability company ("ASI"), FUNLINE MERCHANDISE COMPANY, INC., a California corporation ("Funline"), JEFF HAMILTON COLLECTION, INC., an Arizona corporation ("JHC"), MCARTHUR TOWEL AND SPORTS, INC., an Arizona corporation ("MTS"), RACING COLLECTABLES CLUB OF AMERICA, INC., an Arizona corporation ("RCCA"), TREVCO TRADING CORP., an Arizona corporation ("TTC"), ACTION CORPORATE SERVICES, INC., an Arizona corporation, AW ACQUISITION CORP., an Arizona corporation, CREATIVE MARKETING & PROMOTIONS, INC., a North Carolina corporation, GORACING.COM, INC., an Arizona corporation, GORACING INTERACTIVE SERVICES, INC., an Arizona corporation, RYP, INC., a North Carolina corporation, THE FAN CLUB COMPANY, L.L.C., an Arizona limited liability company (collectively, jointly and severally "Grantor"), in favor of BANK ONE, NA, a national banking association, with its main office in Chicago, Illinois ("Bank One"), in its capacity as Agent ("Agent") for Lenders pursuant to the terms of the Credit Agreement (as defined below).

**WITNESSETH:**

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement, dated as of the date hereof, by and among APC, ARC, ASI, Funline, JHC, MTS, RCCA, TTC, the other Loan Parties, Agent, and Lenders from time to time a party thereto (including all annexes, exhibits and schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement"), Lenders have agreed to make the Loans to the Borrowers (as defined in the Credit Agreement) on the terms and conditions set forth therein;

WHEREAS, in connection with the Credit Agreement and the other Loan Documents, each Grantor shall have executed and delivered to Agent, for itself and the ratable benefit of Lenders, that certain Pledge and Security Agreement dated as of the date hereof (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, each Grantor is required to execute and deliver to Agent, for the benefit of itself and the other Lenders, this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby, jointly and severally, agrees as follows:

1. **DEFINED TERMS.** All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

2. **GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL.** Each Grantor hereby grants to Agent, for the benefit of itself and the other Lenders, a continuing first priority security interest in any of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

(a) all of its Trademarks and any of its rights under any written agreement now owned or hereafter acquired by any Grantor pursuant to which a Grantor obtains any right to use any Trademark (collectively, the "Trademark Licenses") including those referred to on Schedule I hereto;

(b) all renewals or extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and

(d) all products and proceeds of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

This Trademark Security Agreement grants only the security interest herein described, is not intended to and does not affect any present transfer of title to any Trademark registration or application and makes no assignment and grants no right to assign or perform any other action with respect to any intent to use trademark application, unless such action is permitted under 15 U.S.C. 1060.

3. **SECURITY AGREEMENT.** The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to Agent, for the benefit of itself and the other Lenders, pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. **GRANTOR'S USE OF TRADEMARKS.** Notwithstanding the foregoing, each Grantor shall be permitted to control and manage the Trademarks, including the right to exclude others from making, using or selling items covered by the Trademarks, so long as no Default occurs and remains uncured.

5. **AMENDMENT AND RESTATEMENT.** This Trademark Security Agreement, together with the Security Agreement and the other IP Security Agreements (as defined in the Security Agreement), are given in amendment, consolidation, restatement, renewal and extension (but not in novation, extinguishment or satisfaction) of all security agreements, pledge

agreements, assignments and similar agreements delivered pursuant to the Original Loan Agreement.


