RELEASE OF TRADEMARK SECURITY

RELEASE, dated as of September 1, 2005 granted by Lehman Commercial Paper Inc.
("Lehman").

WITNESSETH:

WHEREAS, Salton, Inc. ("Salton") and Lehman, have previously entered into a Guarantee and Collateral Agreement dated as of July 27, 1998 (the "Collateral Agreement"), pursuant to which Salton granted to Lehman a security interest in all of the Trademarks listed on Schedule A attached hereto and forming a part hereof (the "Trademarks");

WHEREAS, Lehman's security interest in BLOCK (AND DESIGN) Reg. No. 752,522 was recorded with the United States Patent and Trademark Office on November 5, 1998 at Reel/Frame: 1811/0752;

WHEREAS, Lehman's security interest in BLOCK (AND DESIGN) Reg. No. 752,528 was recorded with the United States Patent and Trademark Office on November 5, 1998 at Reel/Frame: 1811/0752;

WHEREAS, all proceeds due Lehman which were secured by the Collateral Agreement have been duly satisfied; and

WHEREAS, Salton has requested Lehman to release of record its liens upon the Trademarks and Lehman is willing to release such liens.

NOW, THEREFORE, Lehman hereby releases its entire right and interest in the Trademarks, including the liens and security interests created by the Collateral Agreement, and all liens and security interests granted thereby to Lehman shall hereupon cease and terminate.
