ASSIGNMENT OF SERVICEMARKS AND TRADEMARKS

THIS ASSIGNMENT OF SERVICEMARKS AND TRADEMARKS is effective as of the 1st day of August, 2005, by HK Systems, Inc., a Wisconsin corporation with its principal place of business at 2855 South James Drive, New Berlin, Wisconsin 53151 ("Assignor"), to VG Acquisition Company, Inc., a Delaware corporation with its principal place of business at Eleven South Meramec, Suite 1430, St. Louis, Missouri 63105 ("Assignee").

Simultaneously herewith, Assignee and Assignor are entering into that certain Asset Purchase Agreement, dated as of August 1, 2005 (the "Agreement"), pursuant to which Assignor has agreed to sell to Assignee, and Assignee has agreed to buy from Assignor the Marks (capitalized terms used herein and not otherwise defined herein shall have the same meaning as assigned to them in the Agreement), which are set forth on Appendix A annexed hereto and incorporated herein by this reference.

NOW, THEREFORE, Assignor, for and in consideration of the mutual covenants contained herein and in the Agreement and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Marks, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement of any Mark, whether arising prior to or subsequent to the date of this Assignment of Servicemarks and Trademarks, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Servicemarks and Trademarks not been made.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Servicemarks and Trademarks shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to the principles of conflicts of laws thereof.
