ASSIGNMENT AGREEMENT

This Assignment Agreement (the "Assignment") is entered into as of August 25, 2005 by and between the following two parties:

WHEREAS, ASSIGNOR is the owner of United States trademark "SITEROCK" having registration number 2525905;

WHEREAS, ASSIGNOR is the owner of the internet domain name SITEROCK.COM (the "Domain");

WHEREAS, ASSIGNEE has filed for the trademark registration in Japan of the trademarks "SITEROCK" (in Japanese, in English and in English with a logo mark) with registration numbers 4543106, 4543107 and 4543108;

WHEREAS, ASSIGNOR desires to confirm and conclusively establish that ASSIGNEE is the exclusive owner of such Japanese registered trademarks and related goodwill; and

WHEREAS, ASSIGNOR further desires to assign to ASSIGNEE all right, title, interest and consent held by it and that it is entitled to transfer, to United States and Japanese trademarks "SITEROCK" set forth above (the "Marks") together with the goodwill of the business symbolized thereby in connection with the goods and services on which the Marks are used (the "Property").

NOW, THEREFORE, in consideration of the payment of **FORTY NINE THOUSAND TWO HUNDRED NINETY FIVE U.S. DOLLARS**

(\$49,295.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Marks and Domain together with the goodwill of the business symbolized thereby in connection with the goods and services on which the Marks are used and for which they are registered.

ASSIGNOR represents and warrants that ASSIGNOR has the full right and authority to assign the Marks, Domain and Property and that there is no litigation or any other disputes arising from or relating thereto.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks, Domain and Property. Notwithstanding the foregoing, the registration for the change of the registered owner of the Marks shall be undertaken by the ASSIGNEE and the ASSIGNEE shall bear the registration fees incurred thereby.
