ASSIGNMENT

This Assignment agreement (the "Agreement") is entered into effective as of August 1, 2005 by and between The Merrill Group, Inc., a Florida corporation (hereinafter the "Assignor") as assignor, in favor of Examination Management Services, Inc., a Nevada corporation (hereinafter the "Assignee") as assignee, with reference to the following facts and circumstances:

NOW, THEREFORE, for good and valuable consideration as set forth in the Asset Purchase Agreement between Assignor and Assignee, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer unto Assignee all right, title and interest of Assignor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, as well as its entire right, title and interest in and to all registrations of the Trademarks heretofore granted or applied for, any and all common law rights to the Trademarks in the United States and any state thereof and in any country in the world.

Assignor does hereby expressly agree that Assignee may singly, and without assistance or consent from Assignor, undertake procedures to record the transfer of the Trademarks to Assignee in the United States Patent and Trademark Office or other applicable agency or governmental entity.


This Agreement may be executed in several duplicates, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

In testimony whereof, the parties have caused this Agreement to be executed by their duly authorized representatives.
