**TRADEMARK ASSIGNMENT**

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the following:

- (2) the Application set forth in Schedule B;

together with the business and goodwill symbolized by said Trademark and Application concurrent with the transfer of certain tangible business assets as indicia of said business and goodwill.
