

NOW, THEREFORE, for good and valuable consideration of US \$ 628,000 , the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby sell, assign and transfer unto ASSIGNEE the entire right, title and interest in and to the said trademark **O-EST** and **application Serial No. 76/425,867** to register the same, together with all of the good will of the business represented and symbolized by said trademark, as successor to that portion of the ongoing and existing business of ASSIGNOR to which the trademark pertains, as required by 15 U.S.C. § 1060(a)(1).
