The Director of Trademarks is requested to issue the Certificate of Registration to ASSIGNEE.

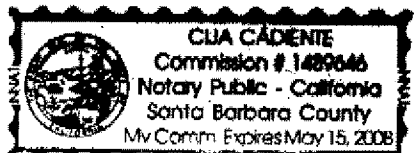
