WHEREAS, Assignee is desirous of acquiring the entire rights, title and interest in and to the aforesaid trademark in the United States of America; and


NOW, THEREFORE, be it known that, for and in consideration of the sum of one dollars (\$1.00) paid to Assignor by the said Assignee, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, by these present, does sell, assign and transfer unto said Assignee, its successors, assigns and legal representatives, the full and exclusive right, title and interest for the territory of the United States of America, in and to the trademark "FORMULA 1" filed with the United States Patent and Trademark Office on March 1, 2004, as United States Trademark Application Serial No. 78/376,343, and Assignor thereby authorizes and requests the Commissioner for Trademarks transfer ownership of United States Trademark Application Serial No. 78/376,343 to said Assignee, as assignee of the entire right, title and interest. Furthermore, Assignor assigns all rights, title and interest to the Assignee for all damages and profits for past infringement of the trademark "FORMULA 1" by any third party.
