PARTIAL TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Partial Termination of Intellectual Property Security Agreement, dated as of April 5, 2005, is executed by Siemens Financial Services, Inc. ("Secured Party"), releasing certain security interests of the Secured Party held pursuant to that certain Intellectual Property Security Agreement dated as of January 15, 2004 in the Trademark Collateral (defined below) owned by Sencorp, Inc.
