ASSIGNMENT OF TRADEMARK

Whereas, Open Harbor, Inc., a Delaware corporation, adopted and used the mark OPEN HARBOR (hereinafter "Mark") in the United States and the Mark is registered in the United States Patent and Trademark Office as follows:

OPEN HARBOR, U.S. Registration No. 2,932,384;

Whereas, TradeBeam, Inc., a Delaware corporation, located and doing business at Two Waters Park Drive, Suite 100, San Mateo, California 94403 ("Assignee"), acquired the Mark in connection with its acquisition of certain of the assets of Open Harbor, Inc. from Uecker & Associates, Inc., as the assignee for the benefit of the creditors of Open Harbor, Inc. ("Assignor"); and

Whereas, Assignee is desirous of confirming its acquisition of said Mark and any and all registrations thereof.

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor confirms that it assigned unto the said Assignee effective December 6, 2004, all its right, title and interest in and to said Mark, together with the goodwill of the business symbolized by the Mark, and the above identified registration thereof. This assignment included the right to sue and recover damages for past and future infringements of Assignor's rights in the Mark and to bring any proceeding in the United States Patent and Trademark Office or any equivalent agency in any other country for cancellation or opposition or other proceeding in connection with said Mark. The right, title and interest is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made.

Assignor further agrees that it will execute, verify, acknowledge and deliver all such further papers, including any instruments of transfer and recordable assignments, and perform such other acts as Assignee lawfully may request from time to time, to perfect and vest title in the Mark in Assignee, or Assignee's successors and assigns.
