TRADEMARK ASSIGNMENT

THIS AGREEMENT is dated as of June 15, 2004.

WHEREAS, Roth Publishing, Inc., a New York corporation having an address at 175 Great Neck Road, Great Neck, NY 11021 (hereinafter referred to as "Assignor"), is the owner of and has adopted, acquired, used and is using exclusively in its business the trademarks listed on Schedule 1 (collectively, the "Trademarks"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign unto Assignee, its successors and assigns, all of its right, title and interest, whether statutory or at common law, in and to the Trademarks, together with all the goodwill of the business symbolized by the Trademarks in the United States and all countries throughout the world, and together with the right to sue and collect damages and/or profits for past infringements of the Trademarks, the intent hereof being to substitute Assignee in the place of Assignor.

To the extent applicable, Assignor further authorizes the Commissioner of Patents and Trademarks of the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this Agreement.


Assignor further agrees to execute such further documents reasonably requested by Assignee and to do such other acts as may be necessary and proper to vest full title in Assignee to the Trademarks and to record Assignee as the owner of the Trademarks herein assigned, at no cost to Assignor.

This Agreement may be executed in several counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument.
