CERTIFICATE AND ARTICLES OF MERGER

ENL MERGING CO. LLC
with and into
ENLIGHTEN.NET, INC.

1. ENL Merging Co. LLC, a Connecticut limited liability company (the "LLC"), shall merge with and into Enlighten.Net, Inc., a Connecticut corporation (the "Corporation"), as authorized pursuant to Section 33-815 and Section 34-193 of the Connecticut General Statutes, as amended, in accordance with the terms of the Plan of Merger duly adopted (such merger is referred to herein as the "Merger"). The name of the surviving corporation is Enlighten.Net, Inc.
2. The Plan of Merger and the performance of its terms were duly authorized and adopted by the sole director of the Corporation. The Plan of Merger did not require approval by the shareholders of the Corporation.
3. The Plan of Merger and the performance of its terms were duly authorized and approved by the sole member of the LLC in accordance with the provisions of Section 34-194 of the Connecticut General Statutes, as amended by Public Act No. 03-18, and in accordance with its organizational documents.
4. The Plan of Merger is on file at the principal office of the Corporation located at 2 Muirfield Lane, Avon, CT 06001. A copy of the Plan of Merger will be furnished by the Corporation, on request and without cost, to any person holding an interest in the LLC or the Corporation.
5. The Certificate of Incorporation of the Corporation immediately prior to the effective time of the merger shall be the Certificate of Incorporation of the surviving corporation without any amendment thereto.
6. This Certificate and Articles of Merger, and the Merger, shall be effective on the date the Secretary of State of the State of Connecticut accepts this Certificate and Articles of Merger.
