NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby sell, assign, transfer and set over to the ASSIGNEE, the trademarks aforesaid, together with the goodwill of the business associated with the marks, the registration hereof and the right to sue for past and future infringements thereof; and ASSIGNOR hereby further covenants and agrees that ASSIGNOR will at any time upon reasonable request, and without further cost to ASSIGNOR, execute such additional assignments and other lawful papers as ASSIGNEE, may deem necessary or desirable, testify in any legal proceeding, make all rightful oaths, and generally do everything possible to aid ASSIGNEE, its successors, assigns, and legal representatives to obtain and enforce proper trademark protection.
