**RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS RELEASE AND REASSIGNMENT dated February 10, 2005 by Harris Trust and Savings Bank, as agent as hereinafter described;

**WITNESSETH:**

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, as agent for the Secured Creditors as defined in the Trademark Collateral Agreement described below (the "*Secured Party*") and SUNROC LLC, a Delaware limited liability company with its mailing address at 60 Starlifter Avenue, Dover, Delaware 19903 (the "*Debtor*") are parties to a certain Trademark Collateral Agreement dated October 12, 2004 which was recorded in the United States Patent and Trademark Office on November 2, 2004 at Reel 002969, Frame 0066, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademarks*"); and

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


