TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 14, 2005, by **HELLER FINANCIAL, INC.**, a Delaware corporation, as Agent (“Agent”).

WITNESSETH:

WHEREAS, Agent and Korden, Inc. (“**Korden**”), were parties to that certain Trademark Security Agreement dated as of May 10, 2002 (the “**Assignment**”; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Assignment), pursuant to which Korden granted a security interest to Agent in, and a collateral assignment to Agent of, among other things, the Trademarks (as defined in the Assignment) as security for certain obligations owing by Korden to the financial institutions (collectively, the “**Lenders**”) from time to time party to that certain Credit Agreement dated as of September 28, 2001 by and among Red Hawk Industries, LLC, Agent, and Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Trademarks set forth on Exhibit A hereto; and

WHEREAS, the Assignment was recorded by the Assignment Division of the United States Patent and Trademark Office on June 3, 2002, at Reel 002517, Frame 0134; and

WHEREAS, Korden has requested that Agent release its security interest in the Trademarks and reassign the same to Korden;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Korden’s right, title and interest in and to all of the following:

(a) each Trademark, Trademark registration and Trademark application, including, without limitation, the Trademarks, Trademark registrations (together with any reissues, continuations or extensions thereof) and Trademark applications referred to in Exhibit A annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, Trademark registration and Trademark application;

(b) each Trademark license and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark license; and

(c) all products and proceeds of the foregoing, including, without limitation, any claim by Korden against third parties for past, present or future (a)

infringement or dilution of any Trademark or Trademark registration including, without limitation, the Trademarks and Trademark registrations referred to in Exhibit A annexed hereto, the Trademark registrations issued with respect to the Trademark applications referred in Exhibit A and the Trademarks licensed under any Trademark license or (b) injury to the goodwill associated with any Trademark, Trademark registration or Trademark licensed under any Trademark license.

2. Agent hereby reassigns, grants and conveys to Korden, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks, and the goodwill of Korden's business connected with the use of and symbolized by the Trademarks.
