**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE, dated as of August 30th, 2005, from JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to MARK IV INDUSTRIES, INC., a Delaware corporation ("Mark IV").

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of September 14, 2000, made by the Grantors (as defined therein), including, without limitation, Mark IV, in favor of the Agent (the "Collateral Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights, dated as of May 31, 2002, among the Agent and Mark IV (the "Security Agreement"), Mark IV, by reference to the Collateral Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in the Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 19, 2002, at Reel 002527 and Frame 0539;

WHEREAS, the Trademark Collateral has been sold by Mark IV, and Mark IV is no longer the owner of the Trademark Collateral; and


WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. As used herein, the term "Trademark Collateral" shall mean the U.S. trademark registrations listed on Schedule A hereto.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in the Trademark Collateral shall hereby cease and become void.
3. Further Assurances. At the expense of Mark IV, the Agent hereby agrees to execute and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
