AMENDMENT NO. 1 TO  
TRADEMARK AND PATENT SECURITY AGREEMENT

THIS AMENDMENT NO. 1 TO TRADEMARK AND PATENT SECURITY AGREEMENT (this "Amendment"), dated as of July 1, 2005, is entered into by DOSKOCIL MANUFACTURING COMPANY, INC., a Texas corporation ("Debtor") and FLEET CAPITAL CORPORATION, as Agent ("Secured Party"), with reference to the following facts:

RECITALS

A. Debtor and Secured Party are parties to the Trademark and Patent Security Agreement, dated as of December 30, 2003 (the "Trademark and Patent Security Agreement"), pursuant to which Debtor granted Secured Party a security interest in all of its Patents, Trademarks and related Collateral as security for the Obligations.

B. The Trademark and Patent Security Agreement makes reference to a Loan and Security Agreement, among Secured Party, the Lenders and the Debtor, dated as of December 30, 2003, (as heretofore amended by Amendment No. 1 and Waiver, dated as of July 23, 2004, Amendment No. 2 dated as of December 25, 2004, Amendment No. 3 dated as of April 29, 2005, and Amendment No. 4 of even date herewith, and as it may hereafter be amended, supplemented or otherwise modified from time to time, the "Loan Agreement").

C. Since the filing of the Trademark and Patent Security Agreement, the Debtor has acquired additional Trademarks and Patents.

D. The Debtor and the Secured Party wish to amend the Trademark and Patent Security Agreement to add these new Patents and Trademarks to Schedule A and Schedule B, respectively, to the Trademark and Patent Security Agreement in order to make such Trademarks and Patents part of the Collateral under the Trademark and Patent Security Agreement.

NOW, THEREFORE, the parties hereby agree as follows:

1. Defined Terms. Any and all initially capitalized terms used in this Amendment (including, without limitation, in the recitals hereto) without definition shall have the respective meanings specified in the Trademark and Patent Security Agreement. The Trademark and Patent Security Agreement is hereby amended such that the definitions set forth in this Amendment shall be incorporated therein by this reference.

2. Addition of New Trademarks. Schedule A to the Trademark and Patent Security Agreement is hereby amended and supplemented by including the Trademarks identified in Schedule A to this Amendment as Trademarks and as part of the Collateral.

3. Addition of New Patents. Schedule B to the Trademark and Patent Security Agreement is hereby amended and supplemented by including the Patents identified in Schedule B to this Amendment as Patents and as part of the Collateral.

4. No Other Amendments. Except as expressly amended hereby, the Trademark and Patent Security Agreement shall remain unaltered and in full force and effect.
