## ASSIGNMENT

This Assignment (this "Assignment") is made and entered into effective as of this 20th day of September, 2005 ("Effective Date") by and between Ragus Holdings, Inc., a Delaware corporation ("Assignor"), and Holly Sugar Corporation, a New York corporation ("Assignee").

WHEREAS, Imperial Sugar Company, a Texas corporation ("Seller"), Assignor, and Southern Minnesota Beet Sugar Cooperative, a Minnesota cooperative association, have executed that certain Stock and Asset Purchase Agreement, dated as of August 16, 2005;

WHEREAS, Assignor owns rights in and to the marks and domain name (including the registrations therefor) identified on Schedule A (collectively, the "Marks") and has established certain goodwill in such Marks;

WHEREAS, Assignor owns all right, title, and interest in and to the patent asset identified on Schedule B ("Patent");

WHEREAS, Assignee wishes to acquire and Assignor wishes to assign all of its right, title and interest in and to the Marks, the goodwill of the business services and products on or in connection with which the Marks are used, and the Patent;

NOW, THEREFORE, in consideration of the foregoing and the mutual representations, warranties, covenants and agreements contained in the Stock and Asset Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign to Assignee all of its right, title and interest in and to the Marks, the goodwill symbolized by the Marks, and the Patent, including without limitation all divisions, continuations, continuations-in-part, reissues, reexaminations, extensions, or equivalents thereof in all pending applications therefore, all foreign counterparts thereof and all pending applications therefore, and all rights of action accrued and to accrue under and by virtue of the Marks and the Patent, including the right to sue and recover for past infringement.

Assignor agrees that it shall, at Assignee's expense, execute and deliver further instruments of conveyance, transfer and assignment (including, causing Seller to execute domain name transfer documentation for Assignor's domain name spreckelssugar.com), as reasonably requested by Assignee, to effectively assign, convey and transfer the Marks, their associated goodwill, the Patent, and all rights therein to Assignee.

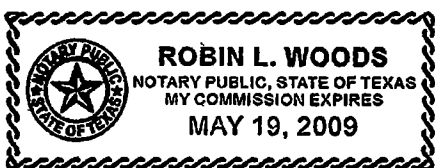


