TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of February 11, 2005 ("Effective Date"), BY AND BETWEEN MURRAY CANADA CO., an unlimited liability company organized and subsisting under the laws of the Province of Nova Scotia, Canada ("Assignor"), on the one hand, AND BRIGGS & STRATTON CANADA INC., a corporation incorporated under the laws of the Province of Ontario, Canada, having its principal office or place of business at Unit #1, 2815 Bristol Circle, Oakville, Ontario L6H 6X5, Canada ("Assignee"), on the other hand.

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement dated as of January 25, 2005 (the "Agreement");

WHEREAS, pursuant to the Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, the United States trademark registrations set forth on Schedule A attached hereto, and the Canadian trademark registrations set forth on Schedule B attached hereto, in each case, together with the goodwill of the business associated therewith (collectively, the "Marks"); and

WHEREAS, Assignee is a successor to that part of Assignor's business to which the Marks pertain, and that business is ongoing and existing.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee the entire right, title and interest in and to the Marks, for Canada, the United States and all foreign countries, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, all rights as an opponent in opposition proceedings, and all other corresponding rights that are or may be secured under the laws of Canada and the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby requests the Registrar of Trade-marks, the Commissioner of Patents and Trademarks, and the corresponding registrars, entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Marks.
