**TRADEMARK ASSIGNMENT OF SECURITY**  
**Corrective Assignment - Nunc Pro Tunc**

WHEREAS, **ROCAWEAR LICENSING LLC**, a limited liability company formed under the laws of the State of New Jersey, with offices at 463 Seventh Avenue, New York, New York 10018 (“Obligor”), has adopted, used and is using the marks shown on the attached Schedule A for which there are applications in the United States Patent and Trademark Office under the numbers shown thereon, and the marks shown on the attached Schedule B for which there are registrations in the United States Patent and Trademark Office under the numbers shown thereon (collectively, the “Marks”); and

WHEREAS, Obligor is obligated to **WELLS FARGO CENTURY, INC.** (f/k/a Century Business Credit Corporation)(the “Lender”) pursuant to, among other documents: (a) that certain Guaranty Unlimited dated July 1, 2002, made by Obligor in favor of the Lender and guarantying the obligations of Roc Apparel Group LLC (f/k/a Urban Menswear LLC)(“RAG”), a New York limited liability company and an affiliate of Obligor, including but not limited to RAG’s obligations under a certain Factoring Agreement dated July 26, 2002, and all related documents and agreements, by and between, RAG and Lender; (b) a certain Trademark Collateral Security Agreement dated July 1, 2002 by and between Obligor and Lender; and (c) a certain letter agreement, dated September 15, 2004, by and between Obligor, RAG, and Lender (as each of the foregoing may be amended, modified, restated or supplemented from time to time, collectively, the “Agreements”); and

WHEREAS, pursuant to the Agreements, and to secure and collateralize Obligor’s obligations to Lender as provided under the Agreements, Obligor has granted to Lender a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor; and

WHEREAS, pursuant to the Agreements, Obligor has executed and delivered to Lender that certain Special Power of Attorney dated July 1, 2002 (the “Power of Attorney”), pursuant to which Obligor appoints and constitutes Lender Obligor’s true and lawful attorney with full power of substitution and with full power and authority, *inter alia*, to assign all right, title and interest of Obligor in and to the Marks, and to record register, file, and accomplish any other formality with respect to same, and to execute and deliver any and all instruments of assignment or other papers necessary or advisable to effect such purpose; and

WHEREAS, the Power of Attorney is and at all times from July 1, 2002 been in full force and effect; and

WHEREAS, on the basis of the Power of Attorney, Lender submitted to and caused that certain Trademark Assignment of Security, relating to the Marks to be duly recorded in the United States Patent and Trademark Office in Reel/Frame 3054/0221 on October 1, 2004 (the “Recorded Assignment”); and

WHEREAS, the Recorded Assignment contains a scrivener’s error in the

description of the Agreements, and the Obligor, hereby confirming and ratifying the recording of the Recorded Assignment and the perfection of Lender's security interest in the Marks, wishes to correct the aforementioned scrivener's error by executing and delivering this Corrective *Nunc Pro Tunc* Assignment, effective as of October 1, 2004, and to cause same to be recorded in the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Obligor does hereby assign unto Lender and grant to Lender a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.






