## TRADEMARK ASSIGNMENT

**Millipore** hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and respective Patent and Trademark Office officials in any country foreign to the United States of America to issue said Registration to **Mykrolis** as the assignee of my entire right, title and interest in, to and under the same, and we hereby further authorize **Mykrolis** to apply for Registration in its own name, as it in its sole discretion sees fit, utilizing any benefits which may exist under any International Agreement, in any country foreign to the United States of America; and

**Millipore** does hereby agree to execute any lawful documents and to testify as to any material fact or thing which **Mykrolis**, its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title and interest in and to and the full enjoyment of said trademark or any part thereof and any Registration, the same to be done without further consideration.
