

OF THE CERTIFICATE OF INCORPORATION  
OF  
WARNER-JENKINSON COMPANY, INC.

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

1. The name of the Corporation is Warner-Jenkinson Company, Inc.
2. The original name under which it was formed was H. Kohnstamm & Co., Inc.
3. The Certificate of Incorporation of the Corporation was filed by the Department of State as of the 28th day of January, 1922.
4. (a) The Certificate of Incorporation is hereby amended to change the name of the Corporation from Warner-Jenkinson Company, Inc. to Sensient Colors Inc.
