**RELEASE OF SECURITY INTEREST IN TRADEMARK**

WHEREAS, Ondo Nalco Energy Services, L.P., a Delaware limited partnership ("Guarantor"), granted a Security Interest in Trademark Rights in favor of Citicorp North America, Inc., as Administrative Agent ("Agent") for the several banks and other financial institutions ("Lenders"), parties to the Credit Agreement, dated as of November 4, 2003 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Nalco Holdings LLC, a Delaware limited liability company, and Nalco Company, a Delaware corporation and parent of the Guarantor ("Borrower"), the Lenders, the Agent, Bank of America, N.A., as Documentation Agent, and Deutsche Bank Securities Inc., J.P. Morgan Securities Inc., Goldman Sachs Credit Partners L.P. and UBS Securities LLC, each as Co-Syndication Agent;

WHEREAS, in connection with the Credit Agreement, the Borrower and Guarantor entered into a U.S. Guarantee and Collateral Agreement, dated as of November 4, 2003, in favor of the Agent, which granted to the Agent for the benefit of the Agent and the Lenders a security interest in Registration No. 1011257 for the mark COREXIT;

WHEREAS, Registration No. 1011257 for the mark COREXIT was incorrectly included on the schedule of marks covered by the Security Interest as the mark is not owned by Guarantor;

WHEREAS, a notice of the security interest was recorded with the United States Patent and Trademark Office against Registration No. 1011257 for the mark COREXIT on December 30, 2003, at Reel/Frame: 2883/0001;

NOW THEREFORE, the security interest in the trademark COREXIT, Registration No. 1011257, is hereby released and discharged in all respects and the notice of security interest recorded with the United States Patent and Trademark Office shall be designated as released.
