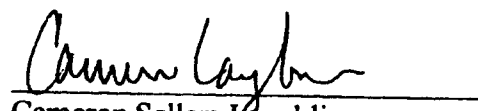
Kevin Surace and Cameron Sellers Laughlin hereby certify that:
