2. Article FIRST of the Articles of Incorporation of said corporation shall be amended to read in full as follows:

"The name of this corporation is MOMENTUM TEXTILES, INC."

3. The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors of said corporation.
4. The foregoing Amendment of Articles of Incorporation has been duly approved by the required vote of shareholders of said corporation in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares entitled to vote with respect to the foregoing amendment was 148,906; and the number of shares voting in favor of the foregoing amendment was 86,455 or 58 percent which exceeded the vote required. Such required vote was more than 50% of the outstanding shares.
