DECLARATION


I am a partner in the law firm Neal, Gerber & Eisenberg LLP and am outside trademark counsel to Polaroid Corporation. On March 31, 2005, a change of name document between OEP Imaging Operating Corporation (as assignor) and Polaroid Corporation (as assignee) was improperly recorded against U.S. Registration Nos. 1445633 and 1480891, which are owned by Odysseum Partners, Inc., at Reel 3056 and Frame 0926.

The chain of title for Reg. Nos. 1445633 and 1480891 should not have been altered as Odysseum Partners, Inc. is and continues to be the owner of the registrations at issue. Thus, the ownership of the registrations never changed and the document recorded at Reel 3056 and Frame 0926 was recorded in error and should be removed.
