On March 31, 2005, a change of name document between OEP Imaging Operating Corporation (as assignor) and Polaroid Corporation (as assignee) was improperly recorded against U.S. Registration Nos. 1355159, 1660322, 1933824, 2322324, and 2330227, which are owned by 3M Company, at Reel 3056 and Frame 0926.

The chain of title for Reg. Nos. 1355159, 1660322, 1933824, 2322324, and 2330227 should not have been altered as 3M Company is and continues to be the owner of the registrations at issue. Thus, the ownership of the registrations never changed and the document recorded at Reel 3056 and Frame 0926 was recorded in error and should be removed.
