Pursuant to the Note and Warrant Agreement (the "Note Agreement") dated January 26, 1993, (as amended and supplemented by thirteen letter agreements dated April 27, 1993, June 15, 1993, March 29, 1994, June 17, 1994, June 30, 1994, October 27, 1994, June 26, 1995, October 18, 1995, January 1, 1996, May 29, 1996, August 29, 1996, October 30, 1996 and January 23, 1997) by and among the Borrowers party thereto PolyMedica Industries, Inc./PolyMedica Pharmaceuticals (U.S.A.), Inc./PolyMedica Pharmaceuticals (Puerto Rico), Inc. (each a "Borrower" and collectively, the "Borrowers") and John Hancock Life Insurance Company, formerly John Hancock Mutual Life Insurance Company (the "Secured Party"), JHMAC Trust 1996 ("JHMAC"), Bankers Trust Company as Collateral Agent for JHMAC (the "Collateral Agent"), and Barnett & Co, the Collateral Agent's nominee name (the "Nominee") (collectively, the "Assignee"), the undersigned Borrowers granted a continuing security interest in and continuing lien upon, the trademarks identified on attached Schedule A to the Secured Party, JHMAC, Collateral Agent and its Nominee as recorded at the Assignment Branch of the U.S. Patent and Trademark Office on September 12, 1997 at Reel 1635 and Frame 0387.
