
Ladies and Gentlemen:



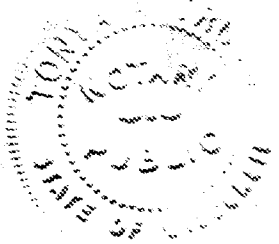
