TRADEMARK ASSIGNMENT

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR ratifies and reaffirms nunc pro tunc as of March 28, 2005, the said assignment to ASSIGNEE of the TRADEMARKS, the entire business or portion thereof to which the TRADEMARKS pertain and the entire right, title and interest in and to the TRADEMARKS together with the goodwill of the business associated with the TRADEMARKS; and

ASSIGNOR does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARKS, the right to sue for and collect the same for its own use and

enjoyment and the use and enjoyment of its successors, assigns and other legal representative;
and

ASSIGNOR further authorized the Commissioner of Patents and Trademarks of the United States to record said Assignment so as to show ownership of the TRADEMARKS in 3AM Labs, Inc., the Assignee; and


ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARKS herein assigned.

This Trademark Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.
