**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL, dated as of September 29, 2005 (the "Release"), is made by UNION BANK OF CALIFORNIA, N.A. ("UBOC"), pursuant to the termination of the Security Agreement (the "Security Agreement"), dated as of August 24, 2004, by and among, UBOC, as Administrative Agent, ENTRAVISION COMMUNICATIONS CORPORATION, a Delaware corporation, and certain Subsidiaries party thereto (collectively, the "Pledgors").

**WITNESSETH**

WHEREAS, pursuant to the Security Agreement, the Trademark Security Agreement by and among the Pledgors and UBOC, dated August 24, 2004 and recorded with the U.S. Patent and Trademark Office on August 30, 2004 at Reel/Frame No. 3041/0914 (the "First Trademark Security Agreement"), and the Trademark Security Agreement by and among the Pledgors and UBOC, dated September 30, 2004 and recorded with the U.S. Patent and Trademark Office on October 26, 2004 at Reel/Frame No. 3068/0010 (the "Second Trademark Security Agreement"), and together with the First Trademark Security Agreement, the "Trademark Security Agreements"), the Pledgors granted UBOC a security interest in all trademark registrations and applications in the United States (the "Trademark Applications and Registrations") and all common law and other rights in and to Trademarks in the United States, any state thereof and foreign countries (the "Trademark Rights") along with the goodwill of Pledgors' business enterprises symbolized by the Trademarks and associated therewith (the "Associated Goodwill") and all proceeds of the Trademark Registrations, Associated Goodwill and Trademark Rights;

WHEREAS, UBOC acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement and the Trademark Security Agreements;

WHEREAS, the Pledgors have requested that UBOC release its security interest in the Trademark Applications and Registrations, Associated Goodwill and Trademark Rights, as defined in the Security Agreement in connection with the termination of the Security Agreement and the Trademark Security Agreements (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, UBOC hereby RELEASES, without recourse, all of its security interest in the Trademark Applications and Registrations listed on Schedule A attached hereto and incorporated herein by reference, Associated Goodwill, Trademark Rights and any other collateral described in the Security Agreement and the Trademark Security Agreements.

UBOC agrees to provide the Pledgors with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.
