## **TRADEMARK RELEASE**

This Release is granted as of September 30, 2005, by DEUTSCHE BANK TRUST COMPANY AMERICAS (the "Collateral Agent") to PANOLAM INDUSTRIES INTERNATIONAL, INC., a Delaware corporation (the "Assignor"), as follows:

### **W I T N E S S E T H:**

WHEREAS, the Assignor has heretofore granted to the Collateral Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications as more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations (as defined in the Second Lien Security Agreement, dated as December 3, 2004, among the Collateral Agent, the Assignor and the other assignors party thereto from time to time (as amended from time to time, the "Security Agreement")); and

WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in and to the Marks to the Assignor and to dissolve any and all liens and encumbrances respecting the Marks shown on the attached Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all right, title and interest in and to the Marks, and more particularly, (i) the security interest in the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the business symbolized by the Marks and (iv) all causes of action arising prior to or after December 3, 2004 for infringement of any of the Marks or unfair competition regarding the same, and granted to the Collateral Agent by the Assignor by the Security Agreement, which Assignment was duly recorded on March 7, 2005 at Trademark Reel 003132, Frame 0948 in the United States Patent and Trademark Office.
