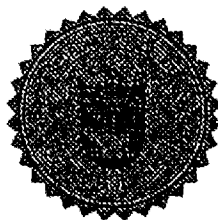

1. That, by Written Consent of the Board of Directors in Lieu of an Annual Meeting pursuant to Section 141(f) of the Delaware General Corporation Law, resolutions were duly adopted by the Board of Directors of the Corporation setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, declaring such amendment to be advisable and calling for consideration thereof by the stockholders of the Corporation. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation of the Corporation shall be amended by striking Article First in its entirety and replacing it with a new Article First as follows:

FIRST: The name of the corporation is The MEDTAP Institute, Inc.

2. That thereafter, the sole stockholder of the Corporation representing one hundred (100%) percent of all the stock of the Corporation executed a Written Consent of Stockholders in Lieu of an Annual Meeting pursuant to Section 228 of the Delaware General Corporation Law adopting the Amendments.

3. The Amendment was duly adopted in accordance with the provisions of Section 242 of the Delaware General Corporation Law.
