BILL OF SALE

Seller and Purchaser have entered into an Asset Purchase Agreement ("Agreement of Sale"), pursuant to which, in consideration of the Purchase Price, Seller agreed to sell, transfer and assign to Purchaser, and Purchaser agreed to purchase and acquire the Assets ("Assets") described in the Agreement of Sale, including without limitation, Seller's interest in the inventory, machinery, office equipment, and supplies of the Business, all of Seller's proprietary rights in and to the Customer Lists for all past and present customers of the Business, and the goodwill of the Business together with all other assets utilized with respect to the Business all as more particularly described in the Agreement of Sale.

Now Therefore, Know All Men By These Presents, that Seller, in consideration of the premises and mutual covenants and agreements contained herein, and for other good and valuable consideration delivered on the date hereof, the receipt and sufficiency of which are hereby acknowledged, intending to be legally bound, does hereby transfer, assign, sell and deliver to Purchaser, its successors and assigns, free and clear of all claims, liens, pledges and encumbrances of any kind, to have and to hold forever, good and valid title in and to the Assets subject to the Agreement of Sale.

From time to time after the date of this Bill of Sale, at Purchaser's request and expense, Seller will execute, acknowledge and deliver to Buyer such other instruments of conveyance and transfer and will take such other actions and execute and deliver such other documents, certifications and further assurances as Purchaser may reasonably request in order to vest more effectively in Purchaser, or to put Purchaser more fully in possession of, any of the Assets transferred hereby.
