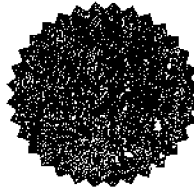

FIFTH: The name of the surviving foreign corporation is LEXISNEXIS PUBLIC RECORDS DATA SERVICES INC.


