**BETWEEN**

- (1) **BTR Industries Limited**, whose registered office is at Invensys House, Carlisle Place, London (hereinafter the "**Assignor**"); and
- (2) **Trelleborg AB** of PO Box 153, SE-231 22, Trelleborg, Sweden (hereinafter the "**Assignee**").

**RECITALS**


- (A) The Assignor is the proprietor and beneficial owner of the UK registered trade marks and applications therefor as set out in schedule 1 hereto (together the "**Trade Marks**").
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee for the consideration hereunder mentioned.



**THE PARTIES AGREE AS FOLLOWS:-**

1. In consideration of the payment of US \$1 (one) and the covenants and agreements set forth herein, the receipt and sufficiency of which are hereby acknowledged by the parties, the Assignor does **HEREBY ASSIGN** and transfer all right title and interest in the Trade Marks, including all statutory, common law rights and goodwill attaching thereto and the right to sue for past and future infringements and to retain any damages obtained as a result of such action, to the Assignee.
2. The Assignor shall its expense do and execute or procure that there shall be done and executed all such documents deeds matters acts and things as the Assignee may at any time require properly to vest the Trade Marks or any one or more of them in the Assignee or otherwise to perfect the Assignee's title thereto.
3. For the avoidance of doubt, the Assignor shall have no obligation to maintain the Trade Marks following the date that is 6 months from 29 February 2000.
4. This Assignment shall be governed by and construed in accordance with English law.
5. Each of the parties to this Assignment hereby submits to the jurisdiction of English courts for purposes of any action brought to enforce any rights or duties under this Assignment.

IN WITNESS whereof this Assignment has been executed as a Deed on the date first above written.


