## TRADEMARK ASSIGNMENT

ASSIGNMENT made as of June 1, 2005, by OUIDAD, INC., a New York corporation (“Assignor”), to OUIDAD LICENSING CORPORATION, a New York corporation (“Assignee”). Assignor and Assignee both have offices located at 37 West 57th Street, 4<sup>th</sup> Floor, New York, NY 10019.

Assignor and Assignee are parties to an Intercompany Assignment and Salon License Agreement dated as of June 1, 2005 (the “Agreement”), pursuant to which Assignor agreed to sell to Assignee and Assignee agreed to buy from Assignor certain Intellectual Property Rights (as defined in the Agreement), including without limitation the trademarks of Assignor. Pursuant to the Agreement, Assignor has agreed to execute from time to time all documents reasonably requested by Assignee to evidence Assignee’s ownership of the Intellectual Property Rights.

In accordance with the Agreement, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignor’s worldwide right, title and interest in, to and under Assignor’s registered and unregistered domestic and foreign trademarks and trademark registrations and applications, including without limitation the trademarks and trademark registrations and applications listed on Schedule A hereto (collectively, the “Trademarks”).

Therefore, Assignor, for and in exchange for the consideration set forth in the Agreement, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor’s worldwide right, title and interest in, to and under the Trademarks, together with the goodwill of the business associated therewith, all rights to sue for infringement of any Trademark, whether arising prior to or subsequent to the date of this Assignment, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.
