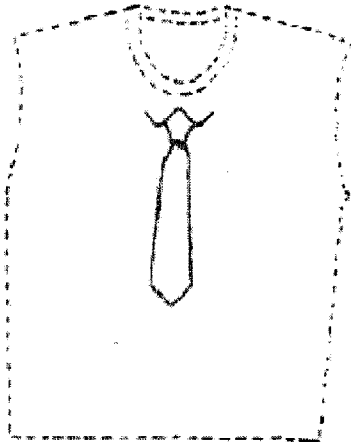

*Now, therefore*, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title, and interest in and to the Design (including all works based upon, derived from, or incorporating the work), including but not limited to all copyright, applications therefor and registrations thereof, trademarks and service marks, applications therefor and registrations thereof, and the goodwill associated therewith, patents and design patents, and applications therefor, rights of publicity, other intellectual property rights, moral rights and any other proprietary rights, with the right to recover and have damages and profits for past infringement, if any. Such includes, but is not limited to:

United States Trademark Registration No. 2746427, issued August 5, 2003; and

United States Patent No. DES. 369,013, dated April 23, 1996.

The territorial scope of this Assignment shall be the entire world.

This Assignment will be governed by and construed in accordance with the laws of the State of Connecticut. All parties agree and consent that jurisdiction and venue of all

matters relating to this Assignment will be vested exclusively in the federal, state and local courts within The State of Connecticut.

If any provision of this Assignment is determined to be invalid by a court of competent jurisdiction, then such determination will in no way affect the validity or enforceability of any other provision herein.

This Assignment may be executed concurrently in one or more counterparts, each of which will be an original, but all of which together will constitute one and the same instrument.
