TRADEMARK ASSIGNMENT

Assignor has transferred, sold, and set over, and, by these presents, transfers, sells, and sets over to Assignee, its successors, legal representatives, heirs and assigns, Assignor's entire worldwide right, title, and interest in and to the Trademarks, all goodwill that such Trademarks represent, and all manifestations of such goodwill, including, without limitation, all common law rights therein and all applications to register and registrations thereof and the goodwill that they represent, and all right, title, and interest therein, on a world-wide basis, as well as the right to sue and collect damages in Assignee's own name for any and all past, present, or future infringement, dilution, or other injury to the goodwill thereof.

2. Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee, its successors, assigns and legal representatives.
