RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of October 11, 2005 (the "Effective Date") among AUTO EUROPE, LLC, formerly known as AE EUROPE, LLC, a Delaware limited liability company, AE EUROPE HOLDINGS, INC., a Delaware corporation, and AE EUROPE GROUP, LLC, a Delaware limited liability company (collectively, the "Grantors"), and CAPITALSOURCE FINANCE LLC, a Delaware limited liability company, as agent for the Creditors (in such capacity, the "Collateral Agent").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated as of December 19, 2003, between the Grantors and the Collateral Agent (the "Security Agreement"; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement), the Grantors granted to the Collateral Agent a continuing security interest in all of their right, title and interest in and to the IP Collateral, including without limitation the trademark registrations and applications set forth on Schedule I hereto (collectively, the "Trademarks"), together with the goodwill associated therewith;

WHEREAS, the Security Agreement relating to the Trademarks was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on January 12, 2004 at Reel 2897, Frame 0274;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the IP Collateral, including, without limitation, the Trademarks together with the goodwill associated therewith, without warranty or recourse.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the IP Collateral, it hereby assigns and transfers such rights, title or interest to the Grantors.

The Collateral Agent shall take all further actions, and provide to the Grantors and each of their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantors to more fully and effectively effectuate the purposes of this Release.
