NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby assign, transfer and convey to Assignee, its successors and assigns, all right, title and interest in, to and under, throughout the universe, free and clear of all liens, claims, charges, security interests, and other encumbrances, the Trademarks, all registrations and applications therefor, together with the entire goodwill attached to the Trademarks, and Assignors' entire right, title and interest in and to any and all claims and demands they may have, at law or in equity, for any infringement, impairment, distortion, or other unauthorized use or conduct in derogation of the foregoing, prior to the date hereof, including without limitation the right to receive all proceeds and damages therefrom.



Assignors hereby irrevocably nominate, constitute and appoint Assignee its true and lawful attorney, with full power and authority in Assignee's name or in the name of Assignors, with full power of substitution, to claim, demand payment or collect and enforce all rights, claims, and interests transferred and assigned hereby, and to prosecute the same at law or in equity, and upon complete discharge thereof, to execute and deliver any and all necessary instruments of satisfaction and release, and to execute and deliver in Assignors' name any and all instruments necessary or appropriate to confirm Assignee's rights to the assets set forth herein.

From the date hereof the Assignors shall cease to use any of the Trademarks.

IN WITNESS WHEREOF, the Assignors have caused this Assignment to be duly executed and delivered as of the date indicated above.




