**TRADEMARK ASSIGNMENT**

This Trademark Assignment is from BNSF Railway Company ("BNSF"), a Delaware corporation, with its principal place of business at 2500 Lou Menk Drive, Fort Worth, Texas 76161 and CNF Inc. ("CNF"), a Delaware corporation with its principal place of business at 3240 Hillview Avenue, Palo Alto, California 94304.

WHEREAS, BNSF desires to convey to CNF, its entire rights, title and interest in and to the IT'S ON TIME OR IT'S ON US mark and to U.S. Trademark Registration No. 2,695,092, which registered on March 11, 2003, for "transportation of goods by intermodal railcars featuring guaranteed on-time delivery," in International Class 39, together with the good will of the business associated therewith and the right to sue for past infringements thereof; and

WHEREAS, CNF desires to acquire BNSF's entire rights, title and interest in and to said mark and registration, together with the good will of the business associated therewith and the right to sue for past infringements thereof;

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, BNSF hereby sells, transfers, and assigns to CNF its entire rights, title, and interest in and to the IT'S ON TIME OR IT'S ON US mark and U.S. Registration No. 2,695,092, together with all common law rights therein and all of the good will of the business associated therewith and the right to sue for any past infringements thereof.
